Subject: Upgrade of the Product Specific Rules of the Generalized System of Preferences, laid down in the Delegated Act of the UCC, to HS2022

The product specific rules of the Generalized System of Preferences are laid down in Annex 22-03 to Regulation (EU) 2015/2446. Annex 22-04 to that Regulation lists the materials excluded from cumulation. For both Annexes, the version of the Harmonized System used in the regulation in force is the version of 2007 (HS2007).

The objective of this analysis is to identify the modifications required on Annex 22-03 and Annex 22-04 to upgrade the classification to the 2022 version of the Harmonized System (HS2022), which will be applicable as from 1 January 2022.

The document does not explain the reasons of the modifications between the different versions of the Harmonized System. It identifies the impact of those modifications on Annex 22-03 and Annex 22-04.

Annex 1 to this document presents the details of the analysis for Annex 22-03.

Annex 2 to this document presents the details of the analysis for Annex 22-04.

Annex 2 – Impact on Annex 22-04 UCC DA of the upgrade from HS2007 to HS2022

From all entries in Annex 22-04, only the 3 Headings below have been modified from HS20007 to HS2022, and require an analysis.

1. Ex 0407

The description of Heading 04.07 in HS2007 is “Birds' eggs, in shell, fresh, preserved or cooked”.

In Annex 22-04, only an extract of the Heading is referred to and the description of the Heading is not replicated as such: “Eggs in shell of poultry, other than for hatching”.

In HS2012, the Heading was replaced (adding subheadings). This does not require an amendment of Annex 22-04.

2. 2009

The description of Heading 20.09 in HS2007 is “Fruit juices (including grape must) and vegetable juices, unfermented and not containing added spirit, whether or not containing added sugar or other sweetening matter”. It is replicated in its entirety in Annex 22-04.

In HS2022, the description is modified to “Fruit or nut juices (including grape must and coconut water) and vegetable juices, unfermented and not containing added spirit, whether or not containing added sugar or other sweetening matter.”.

This requires an amendment of Annex 22-04.

3. 2206

The description of Heading 2206 in HS2007 is “Other fermented beverages (for example, cider, perry, mead); mixtures of fermented beverages and mixtures of fermented beverages and non-alcoholic beverages, not elsewhere specified or included.

The description is amended by HS2022 as follows: “Other fermented beverages (for example, cider, perry, mead, saké); mixtures of fermented beverages and mixtures of fermented beverages and non-alcoholic beverages, not elsewhere specified or included.”

However, as this part of the description is not replicated in Annex 22-04, not amendment is required.
