SITUATION ACTUELLE

- Directives déclaratives concernant les déplacements de stocks (note du 6 novembre 2023)
 - Synthèse de 6 années d'expérience
 - Rappel de la réglementation douanière
 - Validation par la composante centrale
- Difficultés rencontrées
 - Pas de ligne commune
 - Difficulté à obtenir les informations ad hoc
 - >< contenu de l'ordre à déclarer
 - >< analyse de risque client
 - Same level playing field (durée contrôle, sélection, EM, ...) ?
 - Saturation (temporaire) du suivi contentieux

 - Si problématique **fiscale**, dénombrement, concordance packing liste : pas d'intervention (directe) de la douane nécessaire
 - Adaptation des données avec le client
 - Réexportation
 - Destruction
 - Si problématique **RPC**, appel douane
- Pour quels clients ?
 - Nouvel importateur
 - Importateur qui a déjà reçu une DV
 - Aléatoire (taux à fixer)

PoUS PROJECT

- PoUS : Proof of Union Status : new application of TAXUD since 01/03/2024
- 2 phases :
 - T2L/T2LF (01/03/2024)
 - CGM (01/03/2025)
- 2022 :
 - 68.000 T2L/T2LF request in PLDA
 - Paper procedure at arrival
- AS IS : both systems were accepted at the GO LIVE : PLDA or PoUS
→ EO should start to use PoUS

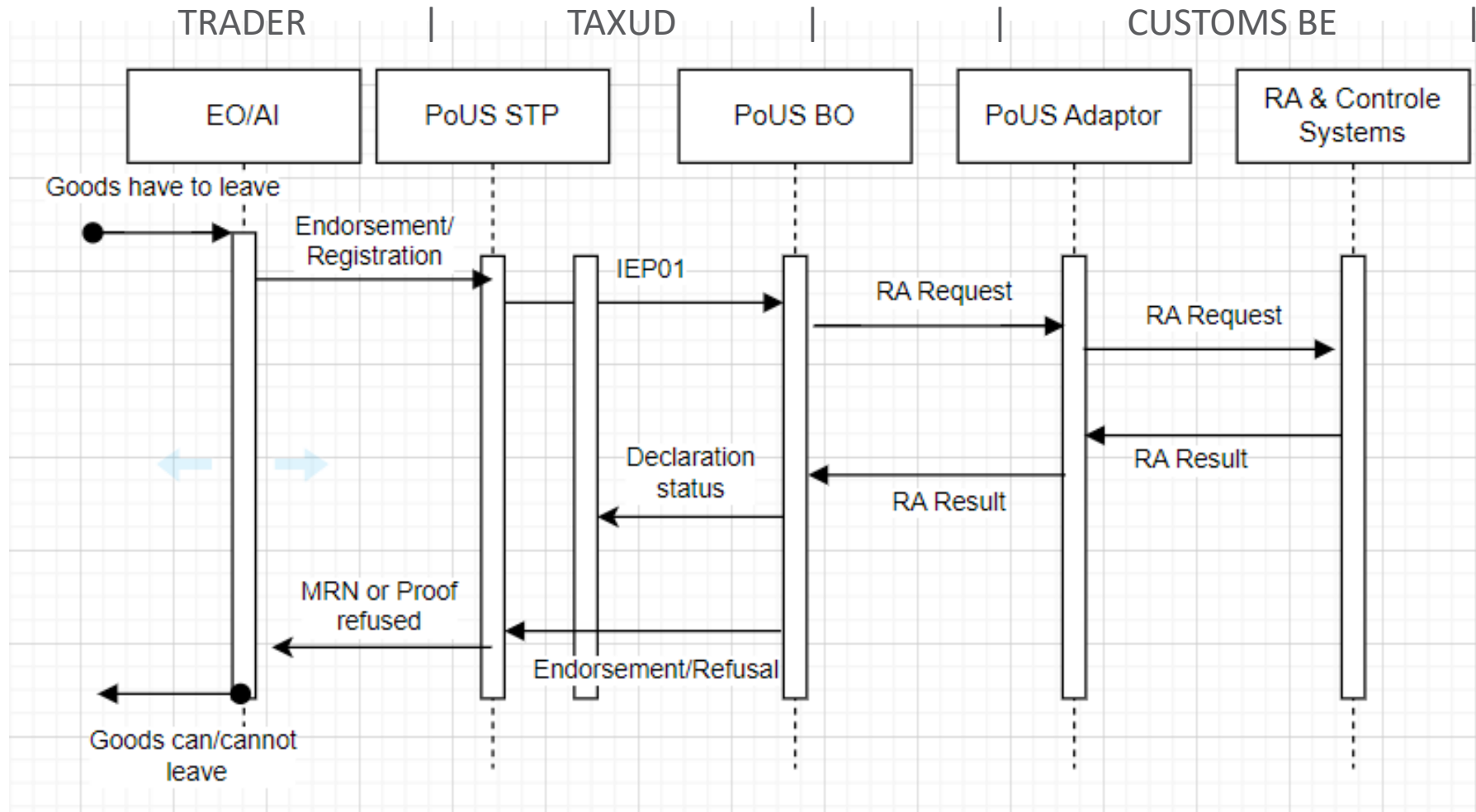


DECLARATION

- At departure : endorsement request/registration (ACP)
- At arrival : PN in PoUS (In september in PN system with API)
- No amendment flow
- No revoke flow

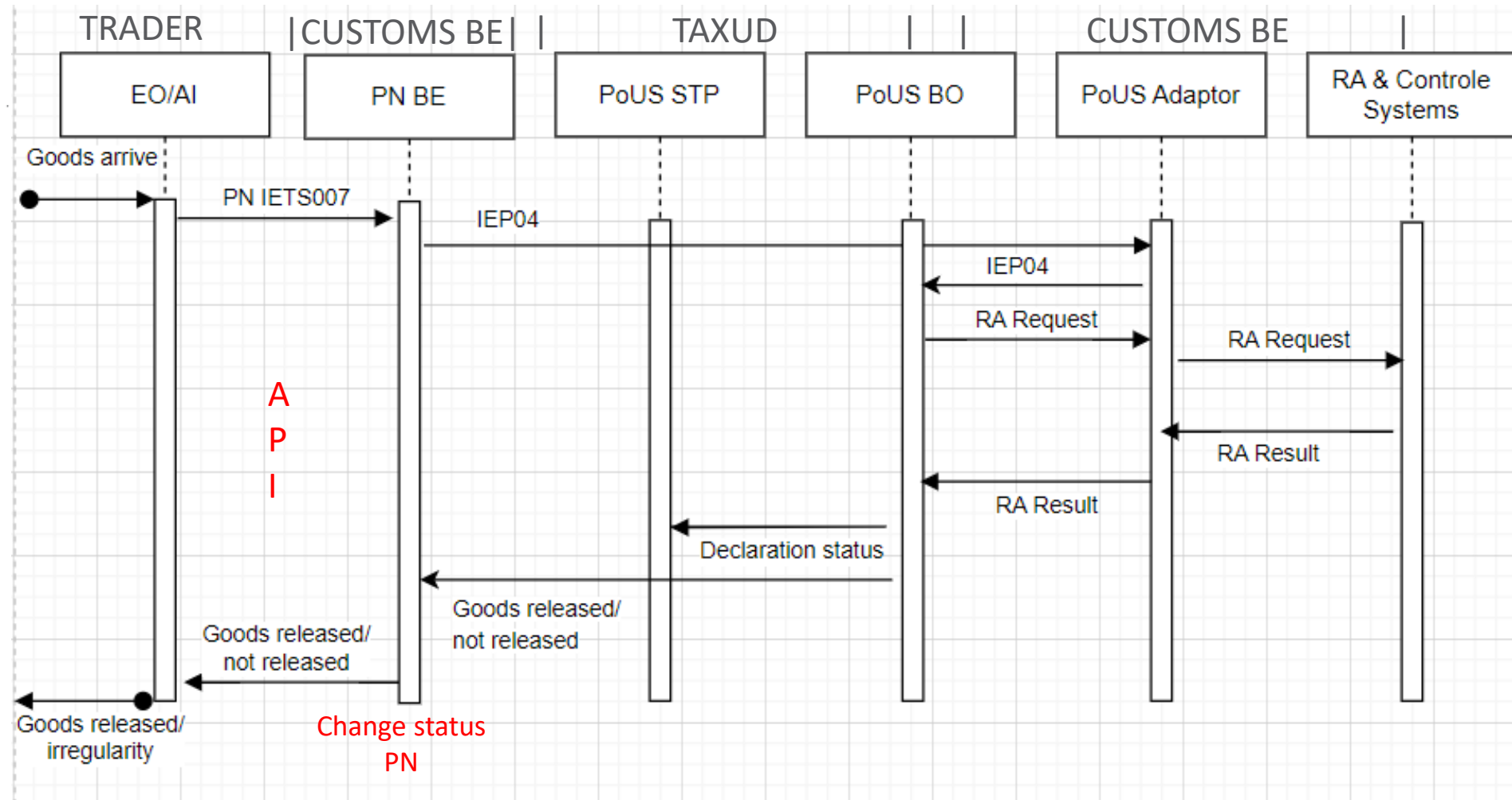


PoUS – SEQUENCE 1/2 DEPARTURE

AUTORISATION : ACP

- ACP : authorized issuer
- To be asked in CDMS
- Simplified flow
- Only matter for the request at departure

IRON AND STEEL PRODUCTS

Regulation (EU) Nr. 833/2014: sanctions towards the Russian Federation.

Art. 3g: Prohibition on import of iron and steel products (ANNEX XVII)

- RU Origin
- Coming from Russia
- Processed in a third country with inputs of RU origin iron or steel products





LEGISLATION

"For the purposes of the application of this point, **at the moment of importation, importers** shall provide **evidence** of the country of origin of the iron and steel **inputs** used for the processing of the product in a third country"

MILL TEST CERTIFICATE

Required for intermediate goods, optional for others

- Name of the factory of production
- Country of the "heat number" (country of the furnace) and HS (6-digit code) of the product
- Country of origin of the inputs OR declaration of absence of Russian iron/steel inputs



END PRODUCTS

MTC (see previous) +

The country where the processing takes place, such as:

- Rolling
- Welding
- Coating
- Extrusion
- ...



OTHER PROOF FOR END PRODUCTS

- Invoices concerning the **production** of the goods
- Delivery statements
- Quality certificates
- (Long term) suppliers' declarations
- Production documents
- Financial documents
- Customs documents of the country of export of the inputs
- Commercial documents
- Clauses in sales contracts
- Declarations of the exporter or the producer concerning the iron and steel inputs used IF they relate to the shipment

documents when
required!**



SOME QUIRKS OF THIS PACKAGE ...

- Returning goods
 - Belgian administration accepts returning goods as a proof of non-Russian origin.
 - Except ... if they return from Russia
 - Exept ...
- Checking/waiting for evidence
 - Warehousing? Not possible because no custom destination can be given
 - ➔ Temporary storage

PRODUCTION RELEASE 27/03/2024

- REN UI, simple print
- REN write-off in PLDA Goods Flow
- LRN uniqueness rules
 - PN: unique LRN per declarant (EORI)
 - TSD: unique LRN per declarant (EORI)
 - Transfer and deconsolidation: LRN = LRN of TSD (for reliable matching)
 - REN: unique per declarant (EORI)
- Check on presence of ENS reference in TSD

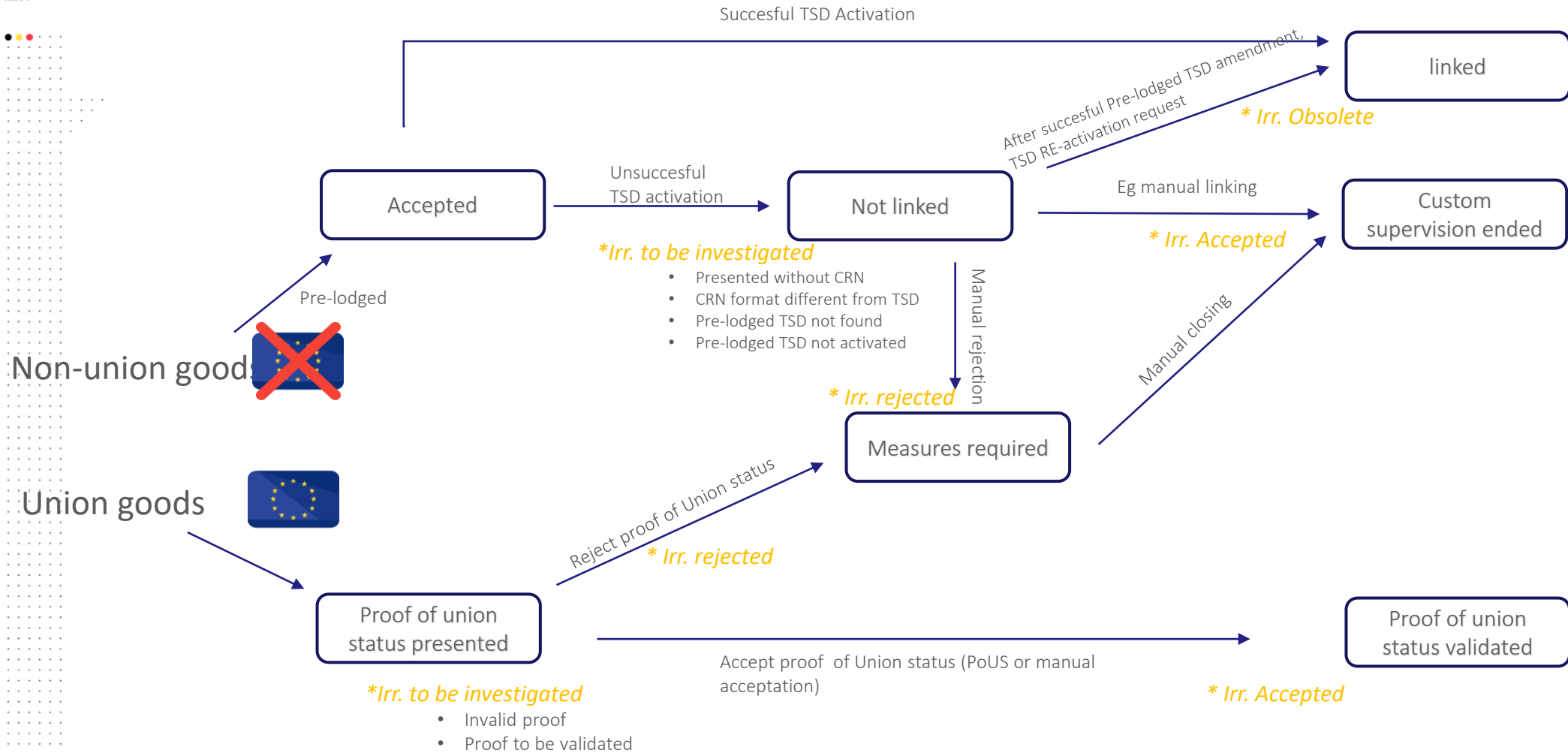


AVAILABLE IN ACC

- New statuses for PN
 - PoUS validated
- IETS045 intermediate message
 - After 60, 70, 80 days
 - With extra data elements for total weight declared/written off and number of packages declared/written off
- Note: ENS re-use testing via 'mock' only
- Potential solution for missing EORI in ACC (TBC)

PN/TS/REN MIG UPDATES

- New PNTS and REN MIGs published
 - Including new xsd and xml
 - PNTS v0.2.1 => v1.0.0
 - REN v0.1.0 => v1.0.0
- Full list of changes provided in the MIGs



PN/TS/REN MIG UPDATES - CTD

- BR for LRN uniqueness for PN, TSD and REN added
- IETS045 end of temporary storage message, intermediate (60, 70, 80 days)
- Automatic TSD re-activation feature explained (after succesful amendment of TSD)
- Extra information for NCTS re-use (transit-based TSD); eg allowed previous doc types
- Updates of several code lists: new statuses for PN...
- IETS906 (tech val NOK) modified cardinality of Original Attribute Value
- CL144 will not be used for validating location codes => workaround via Locomo
- Transfer: between locations of type B only (not new feature, just added info)
- NB: TSD / write-off manual is being prepared – separate from MIG
 - For example: how to fill in authorisations – location codes – warehouse id
 - Instructions for write-off (minimal data sets, business rules...)



WRITE-OFF OPTIONS FOR GA

- In production:
 - REN
 - NCTS4 outgoing transit
- In development/test:
 - PLDA SAD (Single Administrative Document) **for Import**
 - PLDA EIR write-off message
 - IDMS, AES, NCTS5...
- Analysis:
 - EXS in PLDA will **not** write off in the new Goods Accounting; transitional workaround (until EXS in AES) TBD
 - ETD workaround TBD (incoming / outgoing)
 - H7 process under investigation (via TSD/GA?)



UPCOMING PRODUCTION RELEASES

- **Planned for beginning of June 2024**
 - Revoke PN – new message
 - ENS/CR error notifications (closing of ENS lifecycle) – new feedback message
 - IETS045 message expansion
 - (TBC) PoUS integration – automatic validation of T2L/T2LF as PoUS
Requires PN IETS007 message change: include communication details of Person presenting the goods!
- **Planned for September 2024**
 - For maritime sector; mainly related to container release



SNEAK PREVIEW ENS ERROR MESSAGES

- PN closes ENS lifecycle (system sends PN info to ICS2/CR)
- Currently no feedback – is the ENS closed?
- New message in development to send error message from ICS2/CR back to EO
 - Using ‘error pointers’, for example:
 - issue with transport document on MC level
 - Issue with transport document on HC level
 - ...



SNEAK PREVIEW IETS045

- IETS045 end of temporary storage message
 - New element in the message will indicate the IETS045 message 'stage':
 - Intermediate: after 60, 70, 80 days
 - Provisional: when write-off is **considered** complete
(= subsequent declarations accepted in GA, covering all goods in the TSD.
This does **not** end the temporary storage period – need allowance for amendments or invalidations!)
 - Final: at the end of the temporary storage period.
 - Intermediate will not be sent if provisional has been sent before the 60, 70, 80 days.
 - Final message will always be sent at the end of the TS period.
